

Data protection information according to Art. 13, 14 and 21 GDPR

Data protection is very important to us. We process your personal data (hereinafter referred to as "data") in accordance with the legal requirements and would like to do this in a transparent manner. We would therefore like to briefly explain to you in the following data protection information which data we process and for what purposes and on what legal basis this is done. You will also receive information about contact persons and your rights in connection with data processing.

Data processing in the context of the "Leuphana Recruiting Dinner" is carried out in a division of labor between Leuphana Veranstaltungs- und Vermarktungsgesellschaft mbH (LVV GmbH) and Leuphana University of Lüneburg (Leuphana University) within the framework of joint responsibility in accordance with Art. 26 of the General Data Protection Regulation (GDPR). This privacy policy provides information about the data processing that is the responsibility of LVV GmbH and Leuphana University. If, in deviation from this, data processing is carried out under independent responsibility, we will point this out to you.

Purposes and legal basis of data processing:

1) Registration for the "Leuphana Recruiting Dinner"

Leuphana University and LVV GmbH are responsible for the data processing under this section 1.

a) Registration

We use your first and last name, your telephone number and e-mail address for communication for the organization. For your participation in the Recruiting Dinner, we also need your CV. This data is required for the organization and to inform the participating companies. LVV GmbH processes this registration data in the legitimate interest on the legal basis of Art. 6 para. 1 letter f GDPR. The legal basis for Leuphana University of Lüneburg is the fulfillment of the public interest task of preparing for professional activities in accordance with § 3 sentence 1 no. 1 NDSG, Art. 6 para. 1 sentence 1 letter e, para. 2 and 3 DSGVO in conjunction with § 3 para. 1 sentence 1 no. 2 NHG.

b) Name badges

For your presentation at the recruiting dinner, your assignment to a specific company and the resulting possibility of direct contact, we will equip you with name badges at the dinner evening. We use first and last names for this purpose. This data processing serves the effective implementation of the event and is therefore based on the legitimate interest of LVV GmbH in accordance with Art. 6 para. 1 letter f GDPR. The legal basis for Leuphana University of Lüneburg is the fulfillment of the public interest task of preparing for professional activities in accordance with § 3 sentence 1 no. 1 NDSG, Art. 6 para. 1 sentence 1 letter e, para. 2 and 3 DSGVO in conjunction with § 3 para. 1 sentence 1 no. 2 NHG.

2) Photographs

Photos will also be taken during the event, which may include employers and students. We publish selected images on our websites and social media pages and use them to promote future similar events, in particular future events focusing on career choice and entry. Leuphana University uses these images to perform the public interest task of informing the public about the fulfillment of the university's tasks. The data processing is necessary for the fulfillment of this task. The legal basis for this processing is § 3 sentence 1 no. 1 NDSG, Art. 6 para. 1 sentence 1 letter e, para. 2 and 3 GDPR in conjunction with § 3 para. 1 sentence 1 no. 10 NHG. At the same time, this processing represents a legitimate interest for LVV GmbH, the legal basis is therefore also Art. 6 para. 1 sentence 1 letter f GDPR.

Please mark yourself with a sticker/button that you will receive on the day of the event if you do not wish to be photographed. We will then delete the respective images immediately in post-production.

General information:

Even if you do not make use of your rights below, your data will only be stored by us for as long as is necessary for the above-mentioned purposes. This does not apply if a longer storage or retention period is required by law or is necessary for the enforcement of rights within the statutory limitation periods. If data is only stored for the aforementioned purposes, data access is limited to the extent necessary.

We generally keep your data to ourselves and only make it available to those employees who need it for their work as part of the fulfillment of their duties. This does not apply if we are legally obliged to pass it on. We also reserve the right to have some of these activities carried out by third-party providers, provided that they offer sufficient guarantees that suitable technical and organizational measures are implemented in such a way that data processing is carried out in accordance with legal requirements and guarantees the protection of your rights.

We would like to inform you that the provision of your data is neither legally nor contractually required. If you do not provide your data, you will not be able to participate in the Leuphana Recruiting Dinner. Automated decision-making including profiling within the meaning of Art. 22 (1) and (4) GDPR does not take place.

Your right to object pursuant to Art. 21 GDPR:

You have the right to object, on grounds relating to your particular situation, at any time to processing of personal data concerning you.

In this case, we will no longer process this data unless we can demonstrate compelling legitimate grounds for the processing which override your interests, rights and freedoms, or the processing serves the establishment, exercise or defense of legal claims.

Your further rights:

You have the right to request information from us about the processing of data concerning you. In addition to a copy of the data, this right to information also includes the purposes of the data processing, the data recipients and the storage period.

If incorrect data is processed, you can demand that we correct this data immediately. If the legal requirements according to Art. 17 or 18 GDPR are met, you also have the right to immediate erasure or restriction of processing of the data. Please note that it may not be possible to restrict the processing of data.
