Cyberspace is a double-edged sword and a new arena of conflict.

Just as with every new communication platform, its utilization is dichotomous, as the reclaimed virtual ground of liberty can be exploited in a malignant manner.

BACKGROUND

The World Wide Web has been the unprecedented source of information since its establishment in the 1990s and played a crucial role in realizing the right of "access to information".

Internet facilitated the unification of and communication between people regardless of the restriction of movement they might suffer. This helped, in many instances, flagging human rights violations no matter where they occurred. The cyberspace is the space where "freedom of speech" has been exercised even in countries where this is a taboo.

Therefore, oppressive regimes are not in particular happy with the new virtual space and are straining to limit its availability. Intelligence systems and dictatorships have been literally stripped, thanks to the

cyberspace. At the same time, these unmasked autocratic regimes are exploiting internet technology for the surveillance of activists and ordinary citizens expressing opposing political views, often justified by new law amendments in the name of "counter-terrorism".
