2. Revised Subject-specific Schedule 5.2 Staatswissenschaften — Public Economics, Law & Politics to the General Assessment Regulations for Arts and Sciences Masters Programme at Leuphana University Lüneburg Graduate School

Pursuant to the second sentence of section 44 par. 1 NHG [Lower Saxony University Act], the Faculty Council of the Faculty of Business Studies and Economics at Leuphana University Lüneburg approved the following revision of Subject-specific Schedule 5.2 Staatswissenschaften — Public Economics, Law and Politics Major of 01 July 2009 (Leuphana Gazette no. 19/09 of 09 December 2009) to the General Assessment Regulations for Masters Programmes at Leuphana University Lüneburg Graduate School of 21 May 2014 (Leuphana Gazette no. 13/14 of 27 June 2014) on 11 February 2015. The Presidential Committee approved the revised version of the Subject-specific Schedule on 25 March 2015 pursuant to the third sentence of section 44 par. 1 and the third sentence of section 37 par. 1, no. 5 b) NHG.

The **Advanced Modules** (30 CP) are designed to teach in-depth competences in the disciplines involved in the major: politics, economics and law.

International Relations and Democracy (Ma-PELP-7a)

Advanced law module

- Students need to take at least one module from each of the following disciplines: politics, economics and law. The remaining modules can be chosen individually and combined independently.

The **Integration Modules** (20 CP) comprise two comprehensive, research-centred mandatory modules in which students work together to explore selected issues and problems in the field of political science from the perspective of at least two disciplines.

- State, Market and Civil Society (Ma-PELP-5)
- Governance, Democracy and Public Policy (Ma-PELP-8)

The **Masters Forum / Research Perspectives** (45 CP) modules address methods in public economics, law and politics. They also prepare students for the practical demands of research in political science and provide them with support in drafting their Masters dissertations. Section 28 of the General Assessment Regulations

Five months are allowed for the Masters dissertation. An oral examination (Section 7 General Assessment Regulations) in which the candidate presents his or her Masters dissertation and responds to critical questions from the examiners is an integral part of the Masters dissertation. The grade for the oral examination shall be included in the overall grade for the Masters dissertation and shall be worth one fifth of said overall grade.

Entry into force

This revised version of the Subject-specific Schedule shall enter into force following approval by the Presidential Committee of Leuphana University Lüneburg following its publication in the Leuphana University Lüneburg Gazette with effect from the 2015/16 winter semester. It shall replace and supersede Subject-specific Schedule 5.2 of 01 July 2009 (Leuphana Gazette no. 19/09 of 09 December 2009), last amended by the decision of 11 May 2011 (Leuphana Gazette no. 17/11 of 02 September 2011).
