First Amendment of the Subject-Specific Annex 8 Complementary Studies to the Framework Examination Regulations for the Master's Programs at the Graduate School of Leuphana University Lüneburg

On the basis of Section 41 (1) Sentence 2 of the Lower Saxony Higher Education Act (NHG) in the version of February 26, 2007 (Nds. GVBI. p. 69), last amended by Article 1 of the Act of September 11, 2019 (Nds. GVBI. p. 261), the Senate of Leuphana University Lüneburg on 15. April 2020 the following first amendment to Annex 8 Complementary Studies (Leuphana Gazette No. 71/20 of June 17, 2020) to the Framework Examination Regulations for the Master's Programs of the Graduate School of May 21, 2014 (Leuphana Gazette No. 13/14), last amended on November 20, 2019 (Leuphana Gazette No. 20/20 of March 31, 2020). The Presidential Board approved this annex in accordance with § 37 para. 1 sentence 3 no. 5 lit. b) NHG in its meeting on April 15, 2020.

SECTION I

The Subject-Specific Annex 8 Complementary Studies to the Framework Examination Regulations for the Master's Programs at the Graduate School of Leuphana University of Lüneburg is amended as follows:

- 1. In § 1, sentence 1, "major" is changed to "respective courses of study".
- 2. The following changes are made in the module overview "Concerning § 4 RPO, Module Overview Complementary Studies".
 - a) In the box to the left of the "Master's Thesis" field, the word "Major" is replaced with the word "Master's Forum".
 - b) In all other 15 boxes containing the word "Major", the word "Major" is replaced with the words "Subject Specific Area".
 - c) In the box "Reflecting Research Methods 5 CP (Ma-K-2)", the word "on" is inserted after the word "Reflecting".
 - d) In the box "Connecting Science, Responsibility and Society 5 CP (Ma-K-3)", a comma is added after the word "Responsibility".
 - e) In the legend to the module overview, the word "Major" is replaced by the words "Subject-specific area".
 - f) The second paragraph below the module overview is amended as follows:

"Complementary to the discipline-specific areas of each program, the complementary studies program functions as a forum for interdisciplinary exchange, reflecting on the connections and differences between various disciplines and academic cultures."

- 3. In the module table, the corresponding English translations are newly inserted in all three modules.
- 4. In the module table, the word "Reflecting Research Methods (Ma-K-2)" is added after the word "Reflecting" in the module title.

- 5. In the module table, a comma is added after the word "Responsibility" in the module title "Connecting Science, Responsibility and Society 5 CP (Ma-K-3)".
- 6. Below the module table "Regarding § 21 RPO Modules of Complementary Studies" the following new section is inserted:

"Re §24 RPO Gender-Diversity Certificate

(1) The Gender Diversity Certificate confirms the training of gender diversity competences, which enable the reflection and critical analysis of gender relations, access opportunities, social inequality and social heterogeneity. These competencies are acquired in courses that impart theoretical and/ or practical knowledge on gender diversity topics as well as corresponding methodological competencies.

(2) In order to obtain the Gender Diversity Certificate, one of the courses identified as suitable for the Gender Diversity Certificate in the course catalog must be completed in each of the following two modules of the complementary studies, each with a total of 5 CP:

- Engaging with Knowledge and Sciences (Ma-K-1).
- Reflecting on Research Methods (Ma-K-2).

A further 5 CP must be earned either within the framework of a certificate-relevant course in the module "Connecting Science, Responsibility, and Society" (Ma-K-3) of the complementary studies or, if there is free capacity, within the framework of a course in the subject-specific area of a Master's degree program that is designated as suitable for the certificate. In the latter case, the lecturer of the respective module confirms by signature that the student has successfully completed the designated module according to para. 1 or has dealt with gender diversity in selected fields of research and application as a central subject.

(3) If the student has achieved the 15 CP required for the certificate according to para. 2, the Examination Service will issue the Gender Diversity Certificate upon request and upon presentation of the relevant documentation."

SECTION II

The amendment to this Annex shall enter into force on the day following its publication in the official gazette of Leuphana University of Lüneburg.

Regarding § 4 RPO, module overview complementary studies

Subject specific area
Complementary Studies

The complementary studies of the Leuphana Graduate School comprise three modules of 5 CP each (15 CP in total) and are a mandatory part of all master programs of the Leuphana Graduate School with the exception of the programs that teach the prerequisites for a teaching profession.

Complementary to the subject-specific areas of the respective degree programs, the complementary studies program functions as a forum for interdisciplinary exchange and reflects on the connections and differences between various disciplines and academic cultures.

At the same time, this requires an awareness of the limits of one's own discipline in the mirror of the "other", of one's own knowledge and of scientific knowledge production. The forum opens up spaces to understand science and knowledge in context, to acquire interdisciplinary and transdisciplinary competences or to reflect on existing competences and to deal with basic scientific and social questions of ethics as well as complex contemporary issues.

The complementary studies extend and deepen the respective subject-specific areas of the degree programs and complement these with regard to an overarching knowledge orientation, a critically judging ability to reflect and analyze, contingency experiences, a willingness to understand, the ability to cooperate as well as to solve problems in the context of inter- and transdisciplinary competence building and societal challenges.

Re §24 RPO Gender-Diversity Certificate

(1) The Gender Diversity Certificate confirms the training of gender diversity competences, which enable the reflection and critical analysis of gender relations, access opportunities, social inequality and social heterogeneity. These competencies are acquired in courses that impart theoretical and/ or practical knowledge on gender diversity topics as well as corresponding methodological competencies.

(2) In order to obtain the Gender Diversity Certificate, one of the courses identified as suitable for the Gender Diversity Certificate in the course catalog must be completed in each of the following two modules of the complementary studies, each with a total of 5 CP:

- Engaging with Knowledge and Sciences (Ma-K-1)

- Reflecting on Research Methods (Ma-K-2).

A further 5 CP must be earned either within the framework of a certificate-relevant course in the module "Connecting Science, Responsibility, and Society" (Ma-K-3) of the complementary studies or, if there is free capacity, within the framework of a course in the subject-specific area of a Master's degree program that is designated as suitable for the certificate. In the latter case, the lecturer of the respective module confirms by signature that the student has successfully completed the designated module according to para. 1 or has dealt with gender diversity in selected fields of research and application as a central subject.

(3) If the student has achieved the 15 CP required for the certificate according to Para. 2, the Examination Service will issue the Gender Diversity Certificate upon application and after submission of the corresponding documentation.

Entry into force

This Annex shall enter into force on the day following its publication in the official gazette of Leuphana University of Lüneburg.
