Subject-specific Annex 7.1 Social Work Research (M.Sc.) to the Framework Examination Regulations for Master's Programs at the Graduate School of Leuphana University Lüneburg

On November 12, 2025, the Faculty Council of the Faculty of Education at Leuphana University Lüneburg adopted Subject-Specific Appendix No. 7.1 Social Work Research to the Framework Examination Regulations for Master's Programs at the Graduate School of Leuphana University Lüneburg dated September 17, 2008 (Leuphana Gazette No. 15/08 of October 6, 2008), last amended on April 19, 2023 (Leuphana Gazette No. 49/23 of June 16, 2023). The Executive Board approved the subject-specific annex in accordance with § 37 (1) sentence 3 no. 5b) NHG on November 26, 2025.

SECTION I

Regarding Section 2 RPO, aim of the program, purpose of the examination

Subject-specific competencies:

Successful graduates of the master's program

- have a sound and reflective understanding of the most important theories and empirical research in the field of social work research.
- have in-depth knowledge of quantitative and qualitative research methods that are regularly used in the field of international, interdisciplinary social work research.
- have in-depth knowledge of the structures and processes of academic work at universities and non-university research institutes in social work, as well as academic teaching in this field.
- can analyze questions and problems in the context of methodically controlled research, administration, and teaching in social work, and can structure and advance solution processes with the participation of relevant actors.
- are familiar with methods and concepts of interdisciplinary and transdisciplinary research in social work, can apply these in international and national work contexts, and are able to identify, address, and solve empirical questions in a project-based manner with experts from various disciplines and practitioners.
- Are familiar with the state of knowledge in science communication and research ethics.

Personal skills:

Successful graduates of the master's program are able to

- to work responsibly in teams of experts and to fruitfully contribute and actively develop current findings in social work research in academic social work organizations.
- systematically analyze complex problems and research status in social work, develop fundamental and participatory project designs, and successfully support their implementation by applying their in-depth knowledge.
- Deal with problems in a forward-looking manner within a team and lead and take responsibility for group processes against a backdrop of heterogeneity.

- argue complex issues and research findings in social work to practitioners in management and executive positions and work with them to translate these into development strategies.

Regarding § 3 RPO, modularization, study structure and scope, standard period of study

The standard period of study is two years. The scope of study is 120 credit points.

<i>Master's Form: Crafting Literature Reviews</i> [MEd-SozP-8]	<i>Students develop in-depth perspectives on social work research questions that are of particular interest to them. During the seminar, students become familiar with typical review methods, such as systematic, narrative, and integrated reviews, and examine selected research fields according to the current state of research, especially in terms of disciplinary approaches, methodology, and findings. Students form small groups and systematically prepare their knowledge of the research fields that are of particular interest to them and have been identified as relevant in the seminar. They also reflect on their own level of knowledge.</i>	<i>1 Seminar (2 CH)</i>	<i>1 Unsupervised written assignment or 1 Combined assessment</i>	<i>5</i>	<i>English</i>
<i>Quantitative Research Methods</i> [MA-SWR-1]	<i>This module provides a hands-on introduction to quantitative and statistical methods commonly used in social work research. It is organized around the ideal-typical process of empirical research encompassing study planning, data collection, data analysis, and data reporting. Students will develop a deeper understanding of key topics including hypothesis formulation, sample selection, questionnaire development, and both survey and experimental research designs. <i>Teaching Social Work at Universities</i> [MA-SWR-3]	<i>This module examines the didactic foundations of higher education teaching, with a particular focus on social pedagogy as a discipline-specific form of university didactics. Core topics include the development of the discipline and profession, reflection-oriented teaching, and the integration of theory and practice. It further addresses the professionalization of social work practitioners through the design of curricular content, the setting of thematic priorities, diverse teaching and learning formats, and practice-based supervision.</i>	<i>1 Seminar (2 CH)</i>	<i>1 Combined assessment or 1 Unsupervised written assignment</i>	<i>5</i>	<i>English</i>

Alternatively, they can work at a non-university research institute relevant for research on social work. Through practical exercises, students learn how to translate complex research findings into compelling messages for non-academic audiences. Students discuss the social relevance of science communication and consider its potential as a tool for empowerment, advocacy, and evidence-based decision-making.
