Information on Master's Thesis  
(M.Ed. – Social Pedagogy at Vocational Schools)**

The Master's Thesis will usually be written during the fourth semester. The seminars of the module "8000: Master's Thesis" serve as a support format for all students to conceptualize their Master's Thesis.

It is important to reflect that the Master's Thesis is not solely a completed module, but also represents the thesis that you complete your degree program with. Therefore, please focus on a specific topic that you are really interested in and that you have possibly been interested in during a longer part of your studies. In the Master's Thesis, you will get the opportunity to investigate this topic more carefully than before.

To have your Master's Thesis supervised and graded, you are going to need a chief supervisor. Please contact your preferred chief supervisor **no earlier than January 1 of the year in which you are scheduled to complete your studies and, ideally, no later than April 1 of that year**. Ideally, you should do this with a brief written proposal (approx. 1 page) containing your initial ideas for a guiding research question for your Master's thesis.

In addition, you will need a second supervisor for your master's thesis. As a student, you also have the right to make a suggestion for this. If you do not make use of this right, the administrative office of the institute will organize the second supervisor and inform you in good time.

When specifying the topic for your master's thesis and inquiring about potential examiners, please also consider their areas of interest. We recommend visiting the respective personal pages on the homepage for this purpose!

Please note: If you plan to apply for preparatory service for teaching at vocational schools, we strongly recommend that you submit your master's thesis at least 8 weeks before the application deadline for preparatory service. This time is necessary to enable the entire process from assessment to certificate issuance to be completed on time.

You have the option of writing your master's thesis in your minor (Unterrichtsfach). For information on the supervision process by examiners in minors, please contact the relevant coordinators or specific supervisors at the respective institutes.
