

# CONDITIONS OF PARTICIPATION

## LEUPHANA TRANSFORMATIONAL ENTREPRENEURSHIP DAYS

### 1) Subject

Leuphana University Lüneburg (hereinafter referred to as the "Organizer"), Universitätsallee 1, 21335 Lüneburg, is the Organizer of the Leuphana Transformational Entrepreneurship Days 2021 (hereinafter referred to as the "Entrepreneurship Days").

The Leuphana Transformational Entrepreneurship Days will be a three-day online event in which experts from academia and practice will shed light on the topic of "transformational entrepreneurship" and "impact orientation" from the perspectives of entrepreneurship research, entrepreneurship education and practical cooperation. In the context of impact development workshops, ideas will be developed together on how social and sustainable entrepreneurship can shape social transformation. The event is intended to provide impulses for transferring research into practice and thus support entrepreneurs and multipliers in meeting the social, ecological and economic challenges of the present.

The Entrepreneurship Days will take place digitally from 21.09. to 23.09.2021 (each from 9.00 to 12.30). The Organizer will provide participants with the ZOOM tool for communication.

The Organizer is entitled to change the schedule or time for good cause.

Within the framework of the Entrepreneurship Days, content is conveyed in lectures by speakers or jointly developed in workshops with the participation of the participants and guidance by speakers. Details on the program of the Entrepreneurship Days can be found on the website of the Organizer of the Entrepreneurship Days at <https://www.leuphana.de/kooperationen/entrepreneurship/events/entrepreneurship-days.html>.

The Organizer reserves the right to change the conditions of participation at any time.

By registering for the event, the participant\* confirms that he/she has carefully read, understood and expressly agrees to the contents of the following terms and conditions of participation, and that he/she complies with/concedes/assigns all rights and obligations stated herein.

### 2) Registration

Registration is done via an online form that can be completed during the application period indicated on the Organizer's website via the online survey application LimeSurvey (survey.leuphana.de), which is offered as an IT service of Leuphana.

Participation in the Entrepreneurship Days is only possible from the age of 18: Participation of those under 18 is only possible together with a parent.

When registering, all information requested in the registration form must be provided completely and truthfully to the Organizers of the Entrepreneurship Days.

The Entrepreneurship Days have a capacity cap for participants. Therefore, the Organizer

reserves the right to close the application possibility at any time. The Organizer also reserves the right to fill or not fill unclaimed participant places.

The registration becomes effective only after the Organizer has confirmed the registration by e-mail. The participant will receive the access data required for participation in another e-mail. The registration is binding and cannot be transferred to third parties.

It should be noted that the individual program items are only available in real time on the scheduled date and cannot be accessed subsequently.

#### **3) Processing of personal data of the participant**

The Organizer collects and processes data, including personal data related to the overall implementation of Entrepreneurship Days. To the extent that the Organizer is deemed to be the data controller of such data pursuant to applicable laws, the Entrepreneurship Days Organizers shall inform the data subjects about the processing in the Organizer's Privacy Policy and the Organizer shall process such personal data in accordance with the Organizer's applicable Privacy Policy. The Organizer has the right to generate anonymous user data and statistical data from participant data. The Organizer reserves all rights to such anonymized data.

#### **4) Photography and filming by the Organizer**

In the course of the event, the Organizer itself will make visual, audio and/or film recordings.

By registering for the event, the participant consents to the free use by the Organizer and/or third parties of the photographs, sound recordings and film footage made by the Organizer and to their subsequent use in all media, in particular also in media distribution via the Internet. The right of use and exploitation is unlimited in time and space. Furthermore, it includes the distribution in all languages.

The participant acknowledges that information on the Internet is accessible worldwide, can be found by search engines and can be linked to other information. This may mean that personal data (e.g. images) can only be removed with considerable effort or, in individual cases, practically no longer. Information that can be accessed on the Internet can be copied and disseminated by third parties. There is therefore a risk that information published on the Internet can still be found at the original place of publication even after it has been deleted. Insofar as publications are made on social media, the participant is aware that the Organizer has no influence on the number of acts of dissemination there.

The above declaration of consent can be revoked at any time with effect for the future. The

revocation has the effect that published image material is removed from the respective website and no further photos are posted. When posting in certain social media, it cannot be ruled out that complete deletion of the photos is not possible.

The participant acknowledges that it may take up to three working days after receipt of the revocation for the images to be deleted from the website of the Organizer and its commissioned third parties. In the case of printed products, the revocation means that the Organizer will no longer publish the respective image material in new editions of the products already printed.

#### **5) Photography and filming by the participants**

The recording of the course of the Entrepreneurship Days by the participants in audio or video or by screenshots is not permitted without the permission of the Organizer.

#### **6) Rules of conduct and exclusion from participation**

A participant is not allowed to do any of the following:

- to register on behalf of another participant;
- Use the Collaboration Platforms for the transmission of unauthorized advertising, promotional materials, junk mail, spam, chain letters, contests, pyramid schemes, or other forms of solicitation or mass messaging;
- Use any of the Third Party Services used at the Event in an unlawful manner, including but not limited to transmitting any material that contains adware, malware, spyware, software viruses, worms or any other computer code designed to interrupt, destroy or limit the functionality of any computer software or equipment;
- Use any content of the Event Website or any third party services used at the Event in violation of any third party's intellectual property rights, trade secrets or privacy.

Entrepreneurship Days is designed to ensure a safe and enjoyable environment and harassment-free experience for all, regardless of:

- Gender identity and expression
- Age
- Sexual orientation
- Disability
- Physical appearance
- Ethnicity
- Nationality
- Religion
- Political views
- Lack of professional or methodological experience
- Computer experience or lack thereof or
- Chosen programming language or technical skills

We do not tolerate harassment of participants in any form. Sexualized language and images are

not appropriate at any Entrepreneurship Days venue.

Participants who violate these rules may be sanctioned or excluded from Entrepreneurship Days at the discretion of the Organizer.

The Organizer, its employees and their legal representatives as well as their vicarious agents, if any, exercise domiciliary rights throughout the event and are authorized to issue instructions to the participant. Furthermore, the Organizer reserves the right to exclude a participant from further participation in the event that the participant violates or threatens to violate these conditions of participation.

The Organizer reserves the right to suspend, cancel or terminate the event in whole or in part if this is necessary and required to avert an immediate danger to the legal property of a third party.

### **7) Right of use**

The working documents of the speakers are subject to copyright protection and other legal protection rights. The working documents are intended exclusively for the personal use of the participant. Any other use, in particular any transfer, reproduction, public disclosure or other dissemination, is not permitted without the prior written consent of Leuphana University Lüneburg or the respective copyright holder. The provisions of the German Copyright Act apply.

Irrespective of the question of whether a copyright or other property right exists in a specific working document, each participant contractually undertakes by registering to use the working documents only for his/her personal use and to refrain from any further use as described in the previous paragraph.

All rights to the exploitation of the new works created by the participants in the context of the Entrepreneurship Days workshops remain with the participants. Insofar as a participant makes protectable works within the meaning of copyright law accessible to the other participants involved in the implementation of the Entrepreneurship Days, the participant grants the other participants a simple transferable right of use free of charge with regard to all acts of exploitation that are necessary for the implementation of the event. The right of use is limited in time to the duration of the Entrepreneurship Days. Participants declare their agreement that the data/works created by them may be used by the Organizer, in particular as a basis for later publications such as discussion papers.

The participant shall ensure that the granting of rights and the above waiver do not conflict with the rights of third parties. At the request of the Organizer, the participant is obliged to prove how he/she has ensured this. The participant assures that he/she will only contribute his/her own ideas and rights within the framework of the Entrepreneurship Days. The participant is obliged to disclose the use of third party rights in advance.

Participants acknowledge that the Organizer or others may have developed or may develop similar or identical entries, and that they waive any claims resulting from such similarities.

### **8) Liability**

The Entrepreneurship Days are prepared by Leuphana University Lüneburg to the best of its knowledge. Liability and warranty for the correctness, topicality, completeness and quality of the contents and the course are excluded. The Organizer is not responsible and assumes no liability for the content of the participants and does not endorse the opinions contained therein.

The Organizer thus assumes no liability for damages that are not based on gross negligence or intent. Liability for injury to life, body and health remains unaffected.

The Organizer is entitled to make changes to the event at any time, to cancel the event or to cancel it in advance. In this case, the participant has no claim for damages against the Organizer.

Participants are responsible for ensuring that they have the technical requirements (e.g. stable internet connection, state of the art internet browser, speakers, microphone or headset) to participate in the Entrepreneurship Days.

The content on the event website, including but not limited to text, graphics, images, links and other materials, is for informational purposes only. The Organizer does not recommend or endorse any specific software or other information mentioned on the Entrepreneurship Days websites. Reliance on any information provided on the Event Websites is solely at your own risk.

### **9) Final provisions**

This agreement applies only to Entrepreneurship Days and all related services.

If any provision of this Agreement is held invalid, the remainder of this Agreement shall continue in full force and effect.

No agency, partnership or employment is created by these terms.

German law applies to these conditions of participation and the legal relationship arising from them. The exclusive place of jurisdiction for all legal disputes arising therefrom is Lüneburg, insofar as this does not conflict with mandatory law.

Should individual provisions of these Terms and Conditions of Participation be or become invalid in whole or in part, this shall not affect the validity of the remaining provisions.

### **10) Cancellation policy for consumers (for electronic registration)**

The following right of revocation applies only to consumers as defined by § 13 BGB (German Civil Code) and therefore does not apply to contracts concluded with Leuphana University Lüneburg by entrepreneurs as defined by § 14 BGB within the scope of their commercial or independent professional activities.

#### Cancellation policy

##### **Right of withdrawal**

You have the right to cancel this contract within fourteen days without giving any reason. The right of withdrawal is 14 days from the conclusion of the contract.

You can use the attached sample withdrawal form for this purpose, which is, however, not mandatory. To comply with the withdrawal period, it is sufficient that you send the notification of the exercise of the right of withdrawal before the expiry of the withdrawal period.

##### **Consequences of the revocation**

If you revoke this contract, we shall reimburse you all payments we have received from you, including delivery costs (with the exception of additional costs resulting from the fact that you have chosen a type of delivery other than the most favorable standard delivery offered by us), without undue delay and no later than within fourteen days from the day on which we received the notification of your revocation of this contract. For this repayment, we will use the same means of payment that you used for the original transaction, unless expressly agreed otherwise with you; in no case will you be charged for this repayment.
