Fees	Depending on module selection and subject, plus approx. 210 euros per semester in semester fees (not applicable for participation without exams or module study/participation)

Adaptation of working hours: Enabling flexible working hours or part-time models. Study phases: Granting time off for exams and intensive study phases.
